 - Bike Parade
 - Baseball registration was reopened for 3rd grade to 8th grade; still have a few openings to fill teams.
 - Mandatory coaches meeting March 23rd at Barriga's Mexican Restaurant.
 - Wooden Bat league is still open.
 - Girls' softball will be incorporated into the Lee's Summit program.
 - Continue to work on a venue for a Father-Daughter dance.
 - A solar light was ordered for Freedom Park.
