- **Park Board**-Toni Crawford, Park Board President, reported:
  - Easter Eggstravaganza Saturday, April 13<sup>th</sup> 11:00 a.m., Hitt Park.
  - The Park Board is continuing to work on Freedom Fest. They are finalizing the Fun Run event and will be online soon to sign up. Registration will be \$20.00. It will start at 7:00 a.m. on June 29<sup>th</sup>. The run will hit all the parks south of 150 Highway.
  - June 1<sup>st</sup> is Donate to Dump at Hitt Park after the city-wide garage sales, 10:00 am to 2:00 pm. There will also be a donation barrel for non-perishable food items.
  - The first Movies in the Park is June 1<sup>st</sup> at Hitt Park. The movie will be Mary Poppins Returns.
  - There will be a Park Clean Up day on April 27<sup>th</sup> starting at 9:00 a.m. Volunteers needed to help clean up all the parks. Great opportunity for high school students for community service hours. Additional Park clean up days will be announced once the dates are confirmed.
  - Next Park Board meeting is Monday, May 6<sup>th</sup> at 6:30 p.m. at City Hall.

To assist the Gardens of Greenwood with a water source for the gardens at Sunset Park, **Alderman Megee moved that \$12,000.00 be appropriated from the Hydrant Fund for the purpose of running a water line from the southwest corner of Keagon and Peggy west into the park for the purpose of the installation of a fire hydrant.** Alderman McClure seconded the motion. All members present voted in favor. Motion passed.
